This will decrease our cost for infrastructure. Discussion was held on many aspects of how to charge for this land as they will not be assessed for sewer and water in the future. EDA also decided to redraw lot #6 to cut straight along the proposed sewer line and add it to lot #5.

Motion made by Sussner and seconded by Bossuyt to recommend City Council to redraw lot #6 to follow along the proposed sewer line and added to lot #5. Price for the entire purchase to be \$125,000. MOTION PASSED UNANIMOUSLY
